I. Call to order

a) **Thomas Mannor, Supervisor** called to order the regular meeting of **Slagle Township** at **7:30 p.m.**

II. Roll call

III. Approval of minutes from last meeting

a) **Treasurers Report**

Connie Roush, Treasurer, read, the treasurer's report, she reported that the **CD's** are at **\$32,575.35**, **Tax Account** is at **\$1,489.02**, **Fire Millage Savings Account** is at **\$32.22**, **Metro Restricted Fund** is at **\$18,621.24**, **US National Forest Restricted Fund** is at **\$45,002.46**, and **General fund** is at **\$89,512.31**. **ARPA (COVID) Fund** is at **\$26,642.06**.

b) Public Comments:

Connie Roush presented a bid from Guthrie's and Bigelow for clean-up days.

Bigelow's bid came in at \$2,875.

Guthrie's bid came in at \$3,075.00 plus 5.00 per tire. They will have 2 compactors as well as three dumpsters and will except tires and garbage.
